## Community Development update

### New business

#### *Shingle Creek Crossing*

#### **1400 Shingle Creek Crossing –**

#### **Dos Hermanos Mexican Grill & Bar**

The former Applebees restaurant reopened in July as a Dos Hermanos Mexican Grill & Bar. The restaurant has locations in Brooklyn Park and Mounds View. To learn more, <https://doshermanosgrillandbar.com/places/brooklyn-center>

#### **6044 Shingle Creek Parkway – Cavalla Travel**

Longtime Brooklyn Center business Cavalla Travel recently relocated from its former location at 5701 Shingle Creek Parkway to a storefront within Shingle Creek Center. A grand opening was held in late June, and the new space will continue to provide travel agency services, specializing in African tours, and be a retail space with travel accessories and luggage.

### In progress - under construction - Opening soon

#### **6101 Brooklyn Boulevard – Wangstad Commons**

Wangstad Commons was approved last year by the City Council for the construction of a four-story, 54-unit multi-family residential building. All four stories have been framed, the interior spaces are being insulated

and drywalled, and the contractor has been working on the installation of windows and the building exterior. The project has remained ahead of schedule and is anticipated to wrap up by the end of this year.

#### **5501 Xerxes Avenue North – Former Big O Tires**

With the closure of the Big O Tires last fall, Property Owner Totem Foods LLC submitted a Planning Commission Application and received approval from the City Council in February 2024 to convert the former automotive repair shop into a State of Minnesota Department of Public Safety and Division of Driver and Vehicle Services (DVS) inspection station. The location would provide vehicle re-certification inspections on prior salvage vehicles that have since been fully repaired and ensure all parts were obtained legally. As part of the building's reuse, there are plans to remodel the building's interior, update the building's exterior, and replace all site lighting. The renovation is expected to be completed this summer.



#### **5927 John Martin Drive – Affordable Tires (Tire Shop and Auto Detailing)**

The City Council approved a conditional use permit for Property Owner Lin Shuang LLC in May. Following the closure of the Tires Plus location at 5927 John Martin Drive, the Property Owner sought a new tenant for the vacant space next door to New King Buffet. The Owner was contacted by the former operator of Affordable Tires in Brooklyn Park, who was seeking a new space to operate from. The new

operator will provide tire installation and repair services and limited auto detailing services.

#### **5139 Brooklyn Boulevard – Bright Future Child Care Center**

The City Council approved a conditional use permit for Bright Future Child Care Center in May. Owner Denise Fadina is an in-home childcare operator in Brooklyn Center and wants to expand her business to a larger space. Bright Future Child Care Center works through permitting and licensing approvals and will operate out of a portion of Brookdale Covenant Church, located at 5139 Brooklyn Boulevard. #### **1340 Shingle Creek Crossing – Pollo Campero**

Construction is underway for Minnesota's second Pollo Campero location, with plans for additional Twin Cities locations. The approximately 2,600-square-foot restaurant will feature a drive-thru and outdoor patio seating and is anticipated to open by the end of this year. For more information: <https://us.campero.com/>

#### **6098 Shingle Creek Parkway – Treasure Hunt Early Learning Center**

In May, the city council approved a conditional use permit for Keshia Deon, who approached the City about leasing the former Fast Signs location in Shingle Creek Center for an approximately 3,500-square-foot childcare center that would offer child care services from infancy through preschool and has extended operating hours.





### 6160 Summit Drive – Regus

Work continues on an approximately 9,900-square-foot buildout within the 6160 Summit Drive office building. Regus provides flexible workspace, including dedicated office space, co-working, virtual offices, meeting rooms, business addressing, telephone answering, day offices, and hot desks with membership options. #### Under review

### 6440 James Circle North – Los Campeones Gym

Loehrer Acquisitions, LLC has requested review and consideration for approval of a conditional use permit to operate a proposed Los Campeones gym (<https://loscampeonesgym.com/>) at 6440 James Circle North, which was formerly home to the AMF Earle Brown Lanes. If approved, the Applicant would purchase the property and convert the approximately 35,000-square-foot former bowling alley into what would ultimately be the largest Los Campeones location to date. There are currently locations within the Twin Cities metro, North and South Dakota, Colorado, and Texas.



## Meet the inspectors

The City's inspectors, often seen in their white vehicles, are a tech-savvy team. With four housing and code enforcement inspectors, three building inspectors, and a building official, they start their day in the office and then head out to the field. Their use of the latest technology, from managing their calendars to handling data entry and taking calls, ensures their work is efficient and effective. Their work extends beyond property inspections and educating residents on city codes and available programs.

### King Yang, Housing and Code Enforcement Inspector

King is the City's newest inspector, and has been with the City of Brooklyn Center since December 2023. King is responsible for conducting exterior property maintenance inspections throughout the City and does follow-up inspections on property maintenance complaints. As part of the property maintenance inspection process, King may knock on your door to talk about your concerns. Another responsibility that King shares is conducting rental license inspections for our robust rental license program. King does all aspects of the rental license inspections for our robust rental license program.

Away from his work, he enjoys spending time with his wife and kids, watching movies, biking and trying new restaurants.



## Special event permits

Special event organizers must obtain a Special Event Permit from the City at least **45 days** before their planned event.

Event organizers can obtain a permit from the City of Brooklyn Center's Clerk's Office. The permit application will address information about the event and also what, if any city services are needed or requested for the event.

#### The permit applies to the following cases:

- Support services from the City
- Obstruct, delay or interfere with the free and normal use of right-of-way
- Attendance of 100 or more people
- Ancillary activities
- Use of sound amplification, public address system, loudspeaker, and/or other audio devices likely to result in noise levels that will unreasonably disturb others in the immediate area or that constitutes a nuisance; violation of Chapter 19

**Permit exception:** Events intended to allow for the expression of free speech, which do not impede roadways, and are on public property, do not require a permit.

The Brooklyn Center Police Department and Hennepin County Sheriff’s Office have created swap spots, designated public places where residents can exchange items they bought and sold online.

You can use these swap spots for all legal meeting exchanges, such as exchanging property or child visitation exchanges. Swap spots are available at these local locations:

Take these precautions to prevent those who use online transactions as a means to commit crimes:

- Tell a friend or family member where you are going and when you will return.
- If possible, have someone accompany you.
- Conduct exchanges during daylight hours in a public place
- If the item(s) have significant value, consider doing the exchange in a bank parking lot, which would also help you verify the authenticity of the currency.
- Bring a cell phone and make sure it is turned on.
- Trust your instincts. If you identify any red flags or have additional concerns about your safety, cancel your transaction plans.

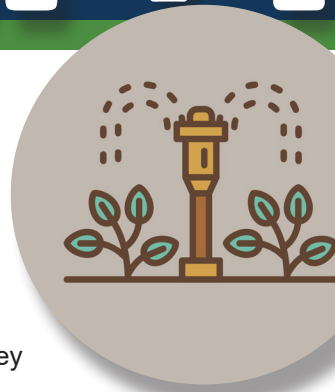

## City of Brooklyn Center watering restrictions: odd-even sprinkling ban (May 1 - September 30)

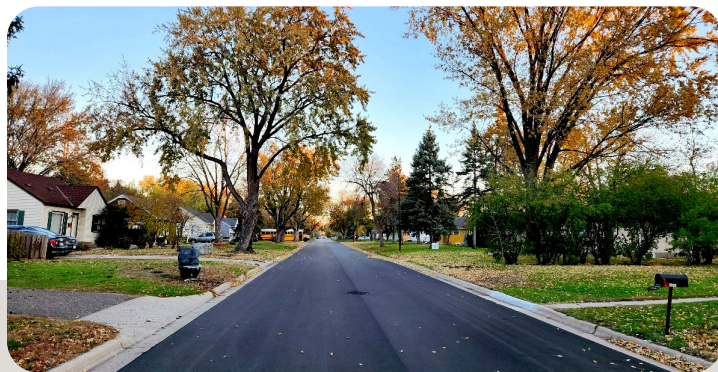
Permanent water restrictions are in effect from **May 1 - September 30** every year according to regulations adopted by the City Council. This odd-even sprinkling ban does not apply to private wells, only to properties on the City's water supply. This ban is defined in Section 4-202 of the City Ordinances. If, after proper warning, any utility user who uses City water is in violation of the odd-even ordinance, they will be charged a \$25 fee per day.



### Lawn and garden water conservation tips

From the American Water Works Association.

- Morning is the best time to water most lawn areas. After about 10 a.m. heat steals moisture from your lawn through evaporation. Water **early** and you can water **less** because more of the water is absorbed into your lawn.
- Do not water out of habit. Water only when your lawn needs it. To test if your lawn needs a soaking, step on the grass. If it springs back up, you do not need to water. If it stays flat, it is time to water.
- Let water sink in slowly. Lots of water is applied quickly and mostly runs off. Let water sink in deep, to encourage deep roots. Lawns with deeper roots will not need watering as often.



### Street and Capital Improvement Program

The City of Brooklyn Center utilizes a Capital Improvement Plan (CIP) to manage and plan its infrastructure and buildings' long-term development and maintenance. This plan, posted on the City's website, covers street, park, public utility improvements, and building maintenance. The CIP is reviewed annually and adjusted based on new information.

If your street address is an **even** number (for example, 5916 or 4500), you may water your lawn and garden on **even-numbered** days of the month (For example: July 10).

If your street address is an **odd** number (for example, 5917 or 4501), you may water your lawn and garden on **odd-numbered** days of the month (For example: July 11).

#### Other tips:

- Use a broom, not a hose, to clean driveways and sidewalks.
- Put a layer of mulch around trees and plants to slow evaporation of moisture and discourage weed growth.
- Check for leaks in pipes, hoses, faucets, and couplings and adjust misaligned sprinkler heads that spray mostly on hard surfaces.
- Do not run the hose while washing your car. Use the hose just to rinse off your car.

The CIP includes a financing strategy that prioritizes and funds these projects using several funding sources. One funding source for street projects is special assessments, which are paid by property owners adjacent to the site. ## Brooklyn Center Water urges customers to 'get the lead out'

In November 2022, Brooklyn Center Water began a comprehensive inventory of our entire water distribution network using records from meter replacement, permits, and maintenance. Service lines are owned and maintained by property owners, not Brooklyn Center Water. And that's the challenge: We don't know which homes have service lines made of lead.

### Lead service line facts:

- Congress banned the use of lead pipe starting June 19, 1986
- The Environmental Protection Agency (EPA) announced the new Lead and Copper Rule Revisions went into effect on December 16, 2021
- Brooklyn Center Water must submit to the EPA a complete inventory of all water service lines and their materials by October 16, 2024
- Approximately 6,890 buildings and homes in Brooklyn Center were built before the lead ban went into effect
- Brooklyn Center Water has more than 9,000 residential and commercial service line connections that need to be verified

We need your help to identify your service-lined material. There are ways to determine if your service line is made of lead.

## Help keep our water safe

Did you know storm drains send water directly into neighborhood ponds, lakes, and rivers? That means anything that goes down the storm drain with the water also ends up in our waterbodies.

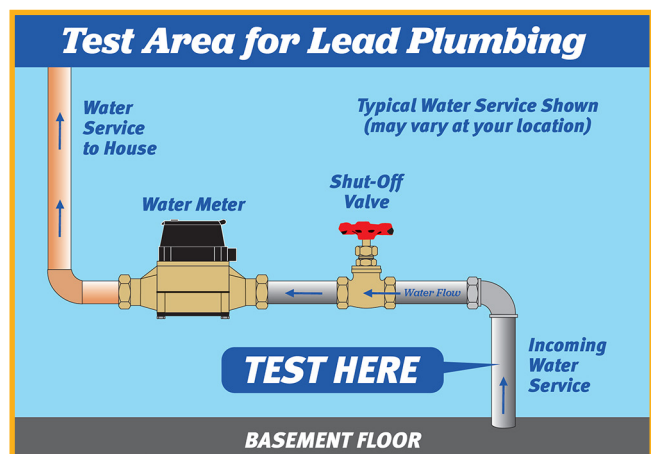
With a few exceptions, an illicit discharge is anything that enters a storm drain that is not rainwater or snowmelt. An illicit discharge is water pollution.

Help protect our ponds, lakes and rivers by reporting illicit discharges. Some of the most common storm drain pollutants are:

- Pesticides and fertilizers
- Paints and solvents
- Laundry wastewater
- Motor oil
- Radiator flushing discharge
- Grass clippings and other yard waste
- Dirt and sediment from construction sites
- Effluent from septic tanks
- Spills from roadway accidents

### Suspect an Illicit Discharge? Report it!

During business hours, call City Hall at **763-585-7100**. After hours, call non-emergency Police dispatch at **763-569-3333**. Call **911** to report a major spill or active illegal dumping.



### Follow these steps to identify your water service material:

1. You will need a key/coin and a refrigerator magnet.
2. Locate your water meter. Look at the pipe that comes through the outside wall or floor of your home and connects to your meter.
3. Carefully scratch the pipe (like you would a lottery ticket) with the key or coin. If the scratch turns a shiny silver color, it could be lead.
4. Place the magnet on the pipe. If the magnet sticks, it's a steel pipe.

### Ways to submit your service line information:

- Use the QR code to submit your information using a short survey.
