RE: 2021 Grandview South Area Reconstruction Project - Informational Meeting

You are cordially invited to an informational meeting to discuss the proposed 2021 street and utility improvements for the Grandview South Area Reconstruction Project:

This provides an opportunity for the public to receive information on the Grandview South Area Reconstruction Project. At this meeting we will present general information regarding the proposed improvement project along with a project layout showing the project area. The proposed neighborhood project includes street and utility rehabilitation on streets as shown on the enclosed map. Engineering staff will be available to address questions.

Project Approval Process

When considering a neighborhood improvement project, the City follows a public information process with neighborhood residents. After the informational neighborhood meeting is conducted, the City Council typically holds a formal improvement hearing at a City Council meeting to receive public comments and decide if the City should continue with the project.

We plan to provide a feasibility report with your comments from the resident questionnaire and from the informational meeting to the City Council on September 28, 2020. We anticipate that the improvement hearing to order the project will be held on October 26, 2020. The City will provide a letter notifying you of the date and time of the improvement hearing as well as a summary of the proposed street and utility improvements for the neighborhood.

Special Assessments

If an improvement project is approved for the Grandview South Area, it would be funded in part by special assessments. The City's Special Assessment Policy provides general guidelines for determining the use of special assessments for public improvement projects. This policy also describes the methods for determining special assessment rates based on land use and zoning designations. It is anticipated that the 2021 Special Assessment rates will be established on November 9, 2020 and the assessment hearing to certify the special assessments on December 14, 2020.

Resident Questionnaire Forms

We have enclosed an additional copy of a questionnaire that was previously mailed out to all residents in the project area. Your cooperation in filling this out and returning it to us is greatly appreciated. Your answers will help us better understand any physical issues and other potential types of improvements you would like to see in your neighborhood. An electronic copy of the questionnaire is also available on the project web page.
