- STREET AND SIDEWALK IMPROVEMENTS
 - Partial Street Reconstruction with Full Depth Pavement Replacement
 - Spot Repair Curb and Gutter and Driveway Aprons
 - o Turf Restoration: Sod Where Impacted Due to Concrete or Utility Work
 - o Tree Replacement: One Tree for Each Tree Removed
 - Sidewalk Improvements:
 - Construct Pedestrian Curb Ramps Within Project Areas with Truncated Dome Detectable Warning Systems.
 - Sidewalk Repairs As Needed or as Impacted on 72nd Ave, Halifax Ave, Noble Ave and Woodbine Ln.
 - Proposed New 6-Feet Concrete Sidewalk along north side of 71st Ave from France Ave to Halifax Ave.
 - Evaluate New 6-Feet Concrete Sidewalk along north side of 73rd Ave from France Ave to Halifax Ave and along west side of Halifax Ave from 73rd Ave to Woodbine Ln.
 - Evaluate Pedestrian Improvements near the intersection of Noble Ave and Woodbine Ln.
- SANITARY SEWER IMPROVEMENTS
 - Line Existing Trunk Sewers Within Public Streets and Easement Areas that were not improved with the 1994 Reconstruction Project (Approximately 60-75 percent)
 - Replace Sanitary Castings and Lids As Necessary Within the Project Area
- WATER MAIN IMPROVEMENTS
 - Replace All Hydrants and Gate Valves
 - Replace All Service Curb Stops at the Property Line (Approximately 10 Feet 15 Feet from Edge of Roadway)
 - Install Insulation at Properties that have Experienced Frozen Water Service in the Past (Approximately 6 Locations)

• STORM SEWER SYSTEM

o Replace Storm Castings and Lids As Necessary Within the Project Area

• STREET LIGHTS

• Replace 1 Wood Pole Free-Standing Light

Note: These are only preliminary estimated amounts - <u>these amounts will change</u>. Costs and funding will be further updated and revised in the feasibility study and final design stages of the project.

PROPOSED ASSESSMENTS

The City has an Assessment Policy that outlines how street improvement projects are funded. Each year the City Council establishes assessment rates for residential and commercial zoned properties based on the City's Special Assessment Policy. The following are estimated 2022 assessment amounts for properties zoned R1.

Assessment Rates for Partial Street Reconstruction with Full Depth Pavement Replacement:

- 2022 Assessment Rates for R1 properties: \$3,777* (street) per property or per equivalent property.
 - *Note: This is only an estimated amount based on a 7.0% increase from 2021 and will be adjusted <u>mid-November</u> when the current Construction Index Cost is available.
- 2022 Interest Rate: 3.5%
 - *Note: It is anticipated that this rate will be adopted by the City Council at the November 8, 2021, City Council Meeting.

Payment Options:

- 1. Pay in full No interest between March and September 30, 2022.
- 2. Pay in full from October 1 to November 18, 2022, with interest from October 1.
- 3. Pay in installments with property taxes over a 10-year period starting in January 2023.
