Applicant’s signature on this renewal confirms: 1) that the premises maintains a dining area open to the general public and provisions for seating a minimum of 30 persons (25 for wine license) at one time (off-sale licenses exempt from this requirement); and 2) real estate taxes, personal property taxes, assessments, or other financial claims of the City, County, or State are not due, delinquent, or unpaid on the premises to be licensed (proof of payment of property taxes must be submitted with renewal application).
