Project Update

Stage 1 - East Portion of Project

The contractor has completed all of the utility replacements, curb and sidewalk spot replacements, the new sidewalks on 71st Ave and 73rd Ave and the first layer of bituminous paving. In early August, they have also completed grading the boulevards and placing topsoil in preparation for sod. They will begin installation of sodding on stage 1. Following the sodding work, the contractor will be continuing miscellaneous work and planting trees as the weather cools. It is anticipated that the final layer of bituminous pavement on the entire project will be installed in early September.

Stage 2 - West Portion of Project

The contractor has completed all of the utility replacements and 90% of the concrete work. They will continue concrete curb and sidewalk spot replacements into early August. Following the completion of concrete work, the contractor will be prepping the boulevard areas for the installation of topsoil and sod. Near the end of August, They will begin removing the bituminous roadway surface to create a new aggregate base for the roadway. Once the new aggregate base has been graded, they will be paving the first layer of bituminous pavement.

Project Hours

In order to maintain the project schedule, the City has authorized the contractor to work from 7 a.m. to 7 p.m., Monday - Friday. Extended hours beyond 7 p.m.

New Sod Care

For those properties in Stage 1 that have or will be receiving new sod in the next couple of weeks, the Contractor is responsible to water for the first 30 days following installation.

After the 30 days, it becomes the responsibility of the homeowners to water and maintain the sod properly. We cannot stress enough that the sod needs proper care including additional watering and fertilizing. Morning is the best time to water most lawn areas because more of the water is absorbed into your lawn. After about 10 a.m. heat steals moisture from your lawn by evaporation. We have enclosed an additional flyer discussing sod care.

In accordance with the enacted city-wide watering restriction, <u>newly sodded areas</u> of the lawn within the project may be watered without restriction until the end of September 2022; however, the existing lawn would still need to follow the water restrictions.

Underground Sprinkler Systems

Tree Replacements


Some property owners had boulevard trees that were removed due to conflicts with curb and gutter or utility replacements. Those property owners have been offered a tree selection from a variety of species as replacements for the removed tree(s). 2022 SPECIAL ASSESSMENT RATES ADOPTED BY CITY COUNCIL

The special assessment rates adopted by the City Council on November 8, 2021, provide for a standard 2022 street assessment rate of \$3,692. Multi-family and commercial properties pay a different rate. The interest rate charged is 3.5 percent.

An official Notice of Public Hearing on the proposed special assessments affecting your property was sent to all property owners on November 18, 2021. If you are a new homeowner the notice regarding this information can be found on the City's Website. The City Council certified these special assessments at their December 13, 2021, meeting.

NOTE: Assessment fees can be paid in full, without interest, through September 30, 2022. From October 1 through the end of the business day on November 18, 2022, you may pay the total assessment with 3.5 percent interest calculated from October 1 to the date of payment. Please contact the Community Development Department at 763-569-3330 for a payoff balance, no bill will be sent. If you choose to not pay the assessments by November 18, 2022, the assessments will show up on your property taxes beginning some time in 2023. If your property taxes are escrowed, your monthly payment may be different, depending on how your mortgage holder calculates your escrow.
